Enough were present for a quorum.

MINUTES

The minutes from the last meeting were published in the ECHO. Dale Greenfield made a motion to accept the minutes as published and David Frock second it. Motion carried.

TREASURES REPORT

Anna Simons was TDY at this time so President Nate Hedin gave the report. The checking account has \$86,584.86, the savings account has \$506.48, and there are 2 CDs at Dakota Bank with no changes. The report suggested that we transfer \$50,000 to savings. As the treasurer, she has the authority to do this without voting. Be sure to fill out expense vouchers and get them back to Nate Hedin. Josh Wermers made a motion to accept the report as presented and Helen Juelfs second it. Motion carried.

COMMITTEE REPORTS

Committee Member At Large – Area 5: Derek Jaeger presented the report on behalf of Rachel Oyen. Rachel attended her first National Conference and it inspired her to become the Area V Committee Member at Large. She is looking forward to gaining for knowledge about the Association overall. For the 2019 Membership Drive, Area V utilized the Area Rep stipend to purchase four \$50 BX gift cards. Anyone who paid their lifetime dues in September was entered into a drawing for one of the gift cards. During September drill there was 23 lifetime





membership dues paid and another 44 annual dues paid. They are planning to set up a table at the Turkey Feed during November drill for members to pay online using the coupon code. Still looking for an OG Rep. Motion to accept the report. Approved. Report will be filed.

Insurance Report was given by Josh Schaefer. The committee has paid out one \$1000 claim. Josh Wermers also mentioned that our Regional Rep will be visiting the full-timers in the near future. The Association gets a certain percentage for all new plans. If your units want to get a brief, let Dave Burr know. Please encourage every member to designate a beneficiary.

Scholarships report was presented by Derek Jaegar. He has updated the 2020 forms and would like to open the application in mid-November and have it close by 7 March 2020. The winners will be announced at the State Conference in April.

Membership report was presented by Tabitha Carr. Current paid membership was at 2405, and she had about 60 forms that still needed to be input. Kelsey and Tabitha got the website updated with new units and eliminated detachments. A 10% discount code has been pushed out. Motion to accept the report. Approved. Report will be filed.

Legislative Report was presented by Josh Wermers. SD is still under recess. Nationally, we are looking at the Veterans Education Program which has received an invitation to give notice in front of Congress to try and beef up our benefits. They will explain the difference between the Guard and the Regular Army on that behalf. Continuing resolution is coming soon, so hopefully they pass a budget. At the end of this year sequestration could come back into effect. Report will be filed.

Resolutions from Nationals was presented by Courtney Tyrrell. SD submitted 4 resolutions and 3 of them were approved by the conference body. The three that were approved were the increase in family SGLI for children, transfer eligibility for Post 9-11 GI Bill, and Tricare Retired Reserve re-evaluation for Gray Area retirees. The resolution that did not pass was TSP contribution after ETS. Judi Perkins is our National Resolutions chairman and she recently sent out

an email stating that a resolution that was submitted and approved at the 2018 National EANGUS conference become law recently. President Donald Trump signed legislation on August 23rd that prevents debt collectors from seizing Veterans disability compensations if they declare bankruptcy. It's called the Honoring American Veterans in Extreme Need or Haven Act. The MOMS Act is close to passing. In total there were 33 resolutions sent to Nationals and 28 passed. Report will be filed.

Publications was presented by Nate Hedin on behalf of Sarah Callies. Deadline for the fall/winter ECHO is 1 October. The summer ECHO was packed full of information. At this time, she has received a History Committee Report from Don List and an EANGUS report from SrA McConnell. Resolutions from National will be included. 
