# **2022 SDNGEA Resolutions**

#### SD Resolution 2022-01-Implementation of Maternity Leave Benefits

Description: Section 603 of the 2021 NDAA authorized 12 drill periods to be paid for maternity leave but additional guidance is needed to implement. Business Case: Army Directive 2022-06 dated 22 April 2022 provided necessary guidance for the Army components to implement paid maternity leave. The Air Force is hopefully following suit but we would like it to be expedited. Proposal: Provide necessary guidance to implement maternity leave benefits as authorized in the 2021 NDAA section 603 in regards to 12 paid drill periods.

#### SD Resolution 2022-02-ANG Federal Tuition Assistance

Description: The ANG ran a pilot program to test the National Guard Federal Tuition Assistance Program, however it was not rolled out due to funding. Business Case: The ARNG has enjoyed this benefit and we would like the ANG to also have this opportunity. With civilian education continuing to have increasing importance for promotions and leadership opportunities, we believe that it is very important to provide additional resources for Airmen to continue their civilian education. Proposal: Fund federal tuition assistance for the ANG.

#### SD Resolution 2022-03-Total Force Policy

Description: We believe that we need to support Directing the Department of Defense to conduct a study and publish a total force policy. This would give both the Reserve forces and the National Guard a clear path forward in their operational training. Business Case: The DoD lacks a current, written, or relevant Total Force Policy. Section 1101 of NDAA 1991 states, "The Department of Defense has not adequately implemented the Total Force Policy since 1973." One could argue that the 1991 NDAA statement is still true over thirty years later. Secretary Melvin Laird initiated the Total Force policy concept in August 1970, over a half-century ago. Six subsequent Secretaries of Defense have issued a notable policy on Active Component (AC) and Reserve Component (RC) Integration. Secretary Gates signed out the last policy in January 2007 principally on limiting mobilizations to 12 months and resetting mobilization to dwell time clocks. Proposal: Support Directing the Department of Defense to conduct a study and publish a total force policy.

#### SD Resolution 2022-04-National Guard Cyber security Support Act

Description: We believe that we need to urge Congress to pass and appropriate funds for HR 2982 and S. 70, which will modify title 32 U.S. Code § 502(f) to allow governors to authorize cyber missions and other training. Business Case: Cyber threats on critical infrastructure are a vulnerability in each state that implicate severe national security risks. National Guard Cyber teams are trained and ready to assess cyber vulnerability and protect networks from cyber-attacks. DoD previously used policy memorandums to guide the use of National Guard personnel and equipment to assist state and local governments in preventing critical infrastructure. Still, these policies are insufficient to meet the current threat. Proposal: Urge Congress to pass and appropriate funds for HR 2982 and S. 70, which will modify title 32 U.S. Code § 502(f) to allow governors to authorize cyber missions and other training.

#### SD Resolution 2022-05-Tax Laws and Policies to establish a tax credit for employers

Description: Update Tax Laws and Policies to establish a tax credit for employers who hire National Guard and Reserve members and retain them through periods of deployment. Business Case: Guard and Reserve service members continue to experience problems maintaining employment because of the demands for meeting the increased operational support provided to active duty. While employers have tried to support national security, it would be naïve to think they are not encountering their problems during these times. Companies are absorbing the cost of replacing service members with temporary employees or increasing overtime to fill the vacancy of mobilizations. Proposal: Provide tax benefits to employers who hire National Guard and Reserve members and retain them through periods of deployment.

# SD Resolution 2022-06-Amend Title 26 USC §62(a)(2)(E) to decrease the distance for the above-the-line deduction for travel expenses

Description: It is time to amend the tax code to change the above-the-line deductions for Guard and Reserve members who travel more than 50 miles from their residence. Business Case: Currently, the law only allows the deduction when performing military duty 100 miles from their home. This change would bring the Guard and Reserve in line with comparable 50-mile criteria for other deductions such as moving expenses and funeral honors. One might say that this is a change that should have occurred ten years ago when the 2005 Defense Base Realignment and Closure Commission

recommended a total of 182 closures or realignment recommendations. History has shown that BRAC implementations result in fewer installations, increasing the distance Guard and Reserve members must travel to perform duty. *Proposal:* Update the distance for above-the-line deduction for travel expenses.

#### **SD Resolution 2022-07-TSP Contribution Limits**

Description: We believe that we need to urge Congress to exempt Title 26 USC 401(k) Guard and Reserve employee and government contribution limits from the new "blended retirement" plan. Business Case: Under the new blended retirement program, some Guard and Reserve members will be forced to surrender some of their civilian retirement if they want to contribute to their military retirement because of contribution limits set by the IRS. Many individuals work in civilian jobs with 401k retirement programs when not in military service. For example, while members could split the \$18,000 (2015) limit between the two places of employment, they would be undercutting their retirement pensions in both their civilian and military retirement plans. EANGUS met with senior leaders from the Pentagon, and they expressed that it was not their intent to reduce retirement benefits for Guard and Reserve through tax law. EANGUS believes this was an unintended consequence due to being unfamiliar with Title 26. Proposal: Urge Congress to exempt Title 26 USC 401(k) Guard and Reserve employee and government contribution limits from the new "blended retirement" plan.

#### SD Resolution 2022-08-Tax Penalties

Description: We believe that we need to urge Congress to update IRS Revenue Procedure 2016-47 to allow Guard and Reserve members on military deployment to qualify for a waiver of the 60-day rollover requirement. Business Case: Of the eleven conditions specified by the IRS as acceptable reasons to request a penalty waiver for exceeding the 60-day rollover requirement, none allow for a release in the event of a military deployment. Some of the conditions the IRS does consider valid to justify a release include the taxpayer losing the check, if a taxpayer's family member died or was seriously ill, and even if the taxpayer was incarcerated. EANGUS believes that a taxpayer who is a military member on deployment should be afforded at least the same consideration as a taxpayer in jail, who faced a postal error, or who dealt with a family illness. IRS Revenue Procedure 2016-47 "... guides waivers of the 60-day rollover requirement contained in §§ 402(c)(3) and 408(d)(3)" in Title 26. The complete list of valid conditions can be found at (https://www.irs.gov/pub/irs-drop/rp-16-47.pdf) Proposal: We believe that we need to urge Congress to update IRS Revenue Procedure 2016-47 to allow Guard and Reserve members on military deployment to qualify for a waiver of the 60-day rollover requirement.

#### SD Resolution 2022-09-Spouse Employment

Description: We believe that we need to urge Congress to create a target group for uniformed services spouses under the Work Opportunity Tax Credits to drive down the unemployment rate while incentivizing businesses with a much-needed tax benefit. 26 U.S.C. § 51(d)(1) Business Case: Since the Reserve and National Guard are considered local military forces, many believe that spouses could not have the same problem with employment as active-duty spouses. However, that is not the case according to the 2017 Military One Source spouse survey that shows a higher unemployment rate for Reserve and National Guard U.S. Army E1-E4s, minority and service members with no college\some college. Because of reductions in military strength for the Reserve Component, many more people are moving for promotion opportunities. Proposal: We believe that we need to urge Congress to create a target group for uniformed services spouses under the Work Opportunity Tax Credits to drive down the unemployment rate while incentivizing businesses with a much-needed tax benefit. 26 U.S.C. § 51(d)(1)

#### SD Resolution 2022-10-Dependent Care Flexible Spending Account

Description: We believe that we need to urge Congress and the Administration to encourage the Department of Defense to offer FSAs to the unformed service Reserve Component performing inactive and active duty. Business Case: Unlike most active-duty families, the opportunity for Reserve Component members to use daycare on installations that offers reduced tuition is almost nonexistent. Offering an FSA would provide them with relief to high daycare costs and is portable for use with off-installation facilities. This is a no-cost, no-share benefit that DoD could provide to Active and Reserve families. Proposal: We believe that we need to urge Congress and the Administration to encourage the Department of Defense to offer FSAs to the unformed service Reserve Component performing inactive and active duty.

Topics discussed included: Full-time National Guard manning issues, Technician Bonuses, Tricare for Federal Employees, Tricare rates for grey area retirees, concurrent receipt offset, MOMS Act, SAD Reimbursement, and Military Construction.

#### Representative of Senator John Thune Jesse Uing

Topics discussed included: National Security and Defense, Second Amendment, Inflation, Energy Independence for America, Protection of the Southwest Boarder, and VA commission recommendation to build new Black Hills VA Hospital in Rapid City while transitioning Hot Springs and Sturgis.

#### Representative of Congressman Dusty Johnson Andrew Christianson

Also discussed topics included: South Dakota National Guards' awards, Military Pay Raises, GI Bill Eligibility, and Defense Spending.

#### NAGUS Chief of Staff COL(R) Paul Drake

Discussed sharing the accomplishments of these professional organizations with others in order to increase membership.

Additional topics discussed included: Emergency funding to help Guard members in times of need, Changes to our Insurance Program, Scholarships,

News and Publications, Professional Development Opportunities in Washington DC, Advocating for Guard Readiness and Quality of Life, Parity with the Active Component – resources and benefits, DD 214 vs NGB 22 for Guard members, Suicide Prevention, and NAGUS Think Tank.

#### Adjutant General's Comments MG Jeffrey Marlette

Thank you for the general body for attending the session and for what all of the Soldiers have done in the past year. Thank you for understanding the value of these organizations and dedicating your time to be here.

National Guard periods of history are always changing and we are currently changing with the international conflicts and the pandemic.

Number one priority remains taking care of Soldiers, Airmen, and their families. Times have been tough but the priority remains.

This past year we had a record number of suicides within the SDNG. We need everyone's help to prevent this from happening. As teammates we need to remain engaged in our force.

Sexual Assaults are still happening in our ranks and cannot be tolerated.

Thankful that we have a governor that understand the National Guard. Governor Kristi Noem is a strong advocate for the guard members.

Vaccine mandates have been tough but it was a direct order. The ANG was not able to pay drill pay for anyone who is not vaccinated starting 1 Jan and has not applied for an exemption, and the ARNG will follow suit on 1 July 2022.

Deployments are still happening and the SDNG has been in every combatant command, and this is not slowing down. Discussing what is the Guard's role



with the Russian / Ukraine conflict, whether with equipment, manpower, or both.

Recognize the fact that the SDNG continues to support to civil authorities. Missions have included mass testing, vaccination support, civil disturbance, wildland fire, search and rescue. Continue to meet all federal requirements in addition to state support.

State Partnership with Suriname is in the best shape that it has ever been in.

Bills related to the SDNG include funding for new Readiness Center in Sioux Falls, addition to the Wagner Armory, possibly add on to the Brookings Armory, Renovation of the Camp Rapid BOQ, New Maintenance Shop in Watertown, Range Road Cold Storage, Drainage projects, additional land purchased near FMS Shop in Chamberlain.

100% State Tuition Assistance is in the work with the Governor and the SD Board of Regents, hopeful that we can get it into a bill during the next business

Tricare for all guard members is being pushed at the national level. Wyoming pushed their state legislator to ensure that their soldiers and airmen were covered by Tricare.

Our South Dakota National Guard museum needs updated and architects have been interviewed. Support is out there to help this happen but it is in its Introduction of Special Guests infancy.

AGR force reduction by 32 slots hurts.

Future challenges include having a timely federal budget, recruiting struggles, aging armories, equipment updates, and vaccine requirements.

Acknowledge the support, dedication and sacrifice from the employers and families.

#### **Assistant Adjutant General (Army) BG** Pat Pardy

Major concern is that recruiting is not keeping up with attrition, not to mention some force structure growth.



This is a National issue as well and this has a lot of ramifications.

The military is becoming a family business; people who are joining our ranks are likely related to someone already enlisted. We need to all help fill the ranks with quality soldiers and airmen

#### Assistant Adjutant General (Air) LTC Sally Ketchum for **BG** Greggory Lair

The SDANG continues to win national awards, most awarded in the National Guard, and has strong Fighter Aviation Heritage.

There will be some leadership changes with promotions and retirements.

End Strength is number one in the nation and has airmen from 20 states.

Vision and mission statements have changed verbiage.

#### **Veterans Community Project LTC(R) Trent Bruce**

This program started a couple years ago in the city of Sioux Falls and ground was broken this past spring. There will be 22 individual homes, 8 family homes, and a VCP Village Community Center.

Mark Solomon, one of the National Organizers of the Veterans Community Project, spoke more about the

project. A few combat vets got together and developed a plan to help veteran housing. There are now 40 full-time staff members and active projects in 6 cities across the nation, hoping to grow by another 8 cities in 2022. Over 3,000 communities have inquired about the organization.

An estimated 40,000 veterans are homeless and 1.5 million veterans live in poverty. Innovative tiny houses and trusted partnerships within the communities are their primary goals. They also help develop other skills to help these veterans succeed after their stay in the village. The average number of days a veterans stays in the village is 444 days and 85% of veterans transitioned to permanent housing.

Outreach Centers are also available to help with more than just housing. They also helped run COVID operations in Kansas City for homeless in the beginning of the pandemic when there were so many unknowns.
